Which fee will you pay?

Government legislation endeavours to give all children 600 hours of pre-school education for their year prior to school through Start Strong Fee Relief. This equates to two days a week. Due to these funding arrangements, if your child is attending for a third day (or more) this will be at an increased cost to the prior days.

The NSW Department of Education requires parents to sign the 'Consent to use and disclosure of personal information' form at the time of enrolment. Your eligibility for Start Strong Fee Relief is conditional upon signing this form.

Start Strong Fee Relief is dependent on which early childhood service is nominated by the parent and is available for children who are:

- four years of age on or before 31 July in that pre-school year
- enrolled for two days per week.

Start Strong Equity Fee Relief is available for children who are:

- at least four years of age on or before 31 July in that pre-school year
- enrolled for two days per week with the following criteria:
 - at risk of significant harm and/or
 - hold a Health Care Concession Card holders (in the name of the parent with the child listed) and/or
 - of Aboriginal or Torres Strait Islander descent and/or
 - have a diagnosed disability or developmental delay.

The unfunded fee is charged when children attend for a third day or more.
